Product use : Coatings: Jotaproff Prima Clean 10 is a washable and durable acrylic paint for interior use. Use as undercoat and top coat where a silky matt finish is desired. Excellent for areas where demands for washability and durability is high.

2. Hazards identification

4. First-aid measures

First-aid measures

- General** : In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and seek medical advice.
- Inhalation** : Remove to fresh air. Keep person warm and at rest. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel.
- Skin contact** : Remove contaminated clothing and shoes. Wash skin thoroughly with soap and water or use recognised skin cleanser. Do not use solvents or thinners.
- Eye contact** : Check for and remove any contact lenses. Immediately flush eyes with running water for at least 15 minutes, keeping eyelids open.
- Ingestion** : If swallowed, seek medical advice immediately and show the container or label. Keep person warm and at rest. Do not induce vomiting.

5. Fire-fighting measures

- Extinguishing media** : Recommended: alcohol-resistant foam, CO₂, powders, water spray.
- Extinguishing media not to be used** : Do not use water jet.
- Recommendations** : Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. Appropriate breathing apparatus may be required.
Cool closed containers exposed to fire with water. Do not release runoff from fire to drains or watercourses.

6. Accidental release measures

- Personal precautions** : Avoid breathing vapour or mist. Refer to protective measures listed in sections 7 and 8. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13).
- Spill** : Preferably clean with a detergent. Avoid using solvents.
- Note: see section 8 for personal protective equipment and section 13 for waste disposal.**

7. Handling and storage

- Handling** : Keep container tightly closed.
Avoid contact with skin and eyes. Avoid inhalation of vapour, spray or mist.
Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed.
Put on appropriate personal protective equipment (see section 8).
Never use pressure to empty. Container is not a pressure vessel.
Always keep in containers made from the same material as the original one.
Comply with the health and safety at work laws.
- When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits.
- Storage** : Store in accordance with local regulations. Store in a dry, cool and well-ventilated area. Keep away from: oxidising agents, strong alkalis, strong acids.
No smoking. Prevent unauthorised access. Containers that have been opened must be carefully resealed and kept upright to prevent leakage.

8. Exposure controls/personal protection

- Engineering measures** : Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction.

- Occupational exposure limits** : Not available.

Personal protective equipment

- Respiratory system** : If workers are exposed to concentrations above the exposure limit, they must use appropriate, certified respirators. By spraying : particulate filter (FFP2 / N95). In confined spaces, use compressed-air or fresh-air respiratory equipment.

- Hands** : Wear suitable gloves.

Recommended, gloves(breakthrough time) > 8 hours: neoprene, nitrile rubber, butyl rubber, Viton, 4H

Not recommended, gloves(breakthrough time) < 1 hour: polyvinyl alcohol (PVA)

For right choice of glove materials, with focus on chemical resistance and time of penetration, seek advice by the supplier of chemical resistant gloves.

The user must check that the final choice of type of glove selected for handling this product is the most appropriate and takes into account the particular conditions of use, as included in the user's risk assessment.

- Eyes** : Use safety eyewear designed to protect against splash of liquids.

9. Physical and chemical properties

10. Stability and reactivity

Stable under recommended storage and handling conditions (see section 7).

Hazardous decomposition products: carbon monoxide, carbon dioxide, smoke, oxides of nitrogen.

Keep away from the following materials to prevent strong exothermic reactions: oxidising agents, strong alkalis, strong acids.

11. Toxicological information

There is no data available on the preparation itself. The preparation is not classified as dangerous according to Directive 1999/45/EC and its amendments.

Repeated or prolonged contact with the preparation may cause removal of natural fat from the skin, resulting in non-allergic contact dermatitis and absorption through the skin. If splashed in the eyes, the liquid may cause irritation and reversible damage. Swallowing may cause nausea, diarrhoea and vomiting.

12. Ecological information

There is no data available on the preparation itself.
Do not allow to enter drains or watercourses.
